- No hostel facility for girls, although there is a hostel for boys but non functional due to infrastructural issues (under construction).

easily and due to scattered population distribution, conveyance facility is also insufficient.

Curricular Aspects

Government Vivekanand P.G. College was established with the aim of imparting knowledge to rural students specially girls. The College believes in realizing the curricular aspects by defining program outcomes and course outcomes that bring out the desired competencies expected. Programs are relevant to local, regional, national development. This institution runs courses in humanities, science and commerce at

both graduate and postgraduate level .Ours is a coeducation institute where gender equity and equality both the norms are being strictly followed . Aiming to serve under priviledged girls students there are 4under graduate and 4 post graduate courses run in our institution along with P.G.D.C.A. & B.C.A. The curriculum of these programs are designed by the affiliating University Sant Gahira Guru University Sarguja Ambikapur Chhattisgarh. College insures effective curriculum delivery through well planned academic calendar, schedule of work, time-table, formal/informal continuous evaluation and monitoring the overall teaching, learning process, Feedback on syllabii are collected from parents, students, alumni and teachers and analyzed. Thrust on development of knowledge and skills are provided through various program in the college in addition to value based education. The college has diverse range of course options catering to varied range both at U.G. & P.G. levels.

Teaching-learning and Evaluation

Nearly 1200-1500 students are admitted in our college annually, following the reservation policy of the state government . Our institution has transparent admission process catering to students from diverse background, specially from economically weaker section of society.

Teachers assess the academic proficiency of students based on their performance in classroom discussions test and assignments. More attention is given to slow learners through Mentor-Mentee scheme..

Students are also mandated to participate in co-curricular activities to highten their experiential learning.

The institute highly targets teaching, educating & guiding students to be responsible and successful in their life. Classroom lectures constitute the primary method of teaching in the college but in this pandemic time, various social media platforms and virtual classroom teaching method has also been employed

Teachers of the college are encouraged to make their classes more interactive by question answer sessions encouraging students to be relevantly critical & analytical in speaking up their mind.

Student are also given assignments on their subjects based on the topics taught to them.

The methods of evaluation followed is on the basis of internal which includes conducting class test, giving them assignment and also the over all response of the students in the class.Secondly external evaluation in a centralized way by the Sarguja university examination of practical papers are conducted in the college by finally appointing external examiner from different colleges. over all evaluation of each student is made based on the performance of the students at the semester & annual examination conducted by the university.

Research, Innovations and Extension

The college is committed to engage faculty members and students in research, innovation and extension activities.

Teachers are encouraged to pursue doctoral and post doctoral studies. At present 3 faculty members are enrolled in different university of the state for their Ph.D. work.

Several research paper in U.G.C. recognized journals have been published and many faculties have

published chapters in books bearing ISBN.

The institution has given importance to research and support the faculty members for research oriented teaching and mainly focuses on research and extension as it is indispensible part of U.G.. & P.G. curriculum.

Seminars, special lectures and workshops are organized to meet the emerging academic and research needs. Faculty member have presented a good member of research papers in various national seminars in their individual capacity and in collabaration with associate which are published in the proceedings of the relevant seminars.

Teachers are motivated to attend faculty devlopment, refresher courses, short term courses from timeto-time for enhancing their knowledge in the field of new research and innovation.

Students from all the P.G. courses M.Com, M.Sc. Chemistry, M.A. political science, sociology are given assignment on the topic like research methodology. Project work and dissertation they are encouraged to present their papers in seminars & workshop organized by other institute.

The institute also involves in extension activities in different categories like community development, social work, Health awareness, blood donation camps, environment awareness, gender sensitization etc. The NSS unit organizes such extension programs along with campus cleaning drive and tree plantation.

The women cell addresses issues related to women staff and girls students like social responsibilities of women and awareness about sexual harassment etc. ;It takes initiatives for guidance and counseling of girl students.

Infrastructure and Learning Resources

Our campus located at the foothill of "siddha baba pahari ", is highly appreciated for the beautiful landscape and cleanliness. with a built up area of approximately 2000sq.mt. in its two campuses, the institute comprises of an array of facilities like, class rooms and laboratories. In all there are 18 room, a seminar hall with capacity of 300 students, laboratories, computer lab, library and reading room, common rooms, gymnasium and canteen.

There are two floors with extension wings, with well ventilated, illuminated, furnished class rooms. every class room has proper ventilation with lights & fans.

The college has an elegant conference/ NAAC hall where various academic and administrative meetings are organized.

The college has well-equipped laboratories with necessary safety measures, in the department of chemistry, physics, zoology, botany, geology, home science and music.

Some class rooms are enabled with ICT facilities the college provides hostel facility for boys coming from near by places and very soon 100 bed girls hostel is going to open as its proposal has been passed by P.W.D.

To ensure the health of students drinking water facility is made available in the building. both the floor has one and more drinking water cooler installed.

The office has adequate number of computers, photocopy machines and printers. for security monitoring CCTV cameras are installed in corridors office and class rooms.

The library of the college has a good number of books including reference books, magazines and Local and National newspapers. presently the library is enriched with the subscription of inflibnet in addition every P.G. department has its own department library.

As food directly affects students health, learning and life time habits, our institute provides a neat and clean canteen where fresh and hygienic food items are a available for the students and staff at a nominal rate.

The college has a big play ground & has a facility for outdoor games and indoor games like kho-kho, volley ball, football, kabbadi, chess, badminton, table-tennis, respectively.

A well defined parking area is available in our campus for vehicles of staff and students.

Student Support and Progression

Our institute supports students to apply for scholarships from government since 2014-15. On an average 45 % of students yearly have availed scholarship .Credence for competitive examination, career counseling and soft skill development are provided, each department takes up extra classes for the low performing students in the examinations. besides regular class room teaching, students are motivated to take part in seminars, workshops on various issues like- women empowerment, AIDS awareness, yoga & meditation are also part of these extra-curricular activities. Girl students are encourage to learn self protection by joining karate classes.

The grievances, harassment complaints related to girls and any request in general is addressed by the grievance and women cell through a transparent mechanism within a time frame from the receipt of the complaint. the menace of ragging is viewed very seriously and anti-ragging cell takes all necessary measures to curb the ragging within the campus.

Besides regular academic courses B.C.A. & P.G.D.C.A. diploma & degree courses have also been started by our institution.

Student help desk cell of our institute helps the students in resolving the issues faced by them during their admission or at the course of their study. It supports the students by providing them with the best possible solutions.

The institute has outstanding performance in extension social outreach activities and in sports & cultural activities. Students have secured state level prizes in sports & cultural events. A number of students

have won university and state level prizes in individual cultural events.

Our performance in sports is peaking in sports with higher participation of students in university, state level competition.

Students are encouraged and given personal attention in preparing notes, seminar reports, dissertation and presentation. 1.1.2 The institution adheres to the academic calendar including for the conduct of CIE

Response:

The Academic calendar is prepared by every department in accordance to the university academic calendar and the faculties create and maintain plan for the whole session and communicate the same to the students. In the beginning of each curricular session meeting is held to decide the subject allocation and for the preparation of the institutional academic calendar.

The class room transactions, assignments, seminars, group discussion, sessional/periodical examinations for continuous evaluation are followed as per the institutional academic calendar. However, the institution follows the list of holidays and celebrate some other events as per the Higher Education Department of the Chhattisgarh Government.

The syllabus of each department. is divided into five consecutive units according to the calendar. Classroom teaching is enriched by adding various skill development programs, lectures, discussion, debates etc.

The Learning Outcomes of the courses are assessed with the help of oral and written tests. Syllabus is completed within the specified time frame and in addition the teachers also conduct extra classes for doubt clearance and revision of chapters for the benefit of the slow learners.

The faculty members try to correlate the subject matters to life situations making it more meaningful and interesting, which also can be viewed as an approach to value addition to the theoretical knowledge provided by individual subjects.

The institution has a systematic mechanism to assess the learning outcomes and the teaching pattern is student centric where collaborative learning strategies are employed. Experimental learning, participative learning and problem-solving methodologies are applied in various curricular and co-curricular activities. And in doing so, improved ICT tools are used for effective instruction and class transactions. Study materials, previous year question papers, power point presentations, assignments, audio-video lectures *etc.* are made available to the students.

2.2 Catering to Student Diversity

2.2.1 The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

Response:

The institution assesses the learning levels of the students, after admission and organizes special programs for advance as well as slow learners, according to the need.

The institution provides quality education to the students and in doing so, makes various efforts to ingress the learning levels of students starting soon after the completion of the admission processes. Institute has a variety of students representing the various socio-cultural, regional and economic backgrounds. Which makes it important to differentiate the slow learners from the advanced learners at the entry level. Lists are prepared for slow and advances learners taking into consideration the previous year marks obtained by the students. In the beginning of every academic year, newly admitted students are guided and motivated properly by counseling sessions. The mentors start the process of identification of the students learning levels, interests, articulation, abilities and prospects through interpersonal interactions in classrooms and laboratories, during departmental seminars and also by evaluating their performance levels in class tests, which help the teachers in evaluating the students learning levels. This also helps the students self-analyze their performance levels and understand as well as identify therespective problem areas related to the contents. This assist in categorization of the advance learner and slow learners, so that the mentors can provide required assistance to the students and suggest them to enroll in one of the extension activities viz: NSS, Red Cross, Women Cell as per their aptitude.

Certain measures those are opted for enhancement of skills in slow and advance learners are:

- Extra classes for problem solving (doubt classes) so that slow learners have betterunderstanding, average learners improve their grades and advance learners can augment their skills.
- Group studies and discussions supervised by the teacher.
- Assignments and study materials are provided by the teachers.
- Students solve the pervious years examination question papers.
- Personal counseling and interaction with the parents.
- Measures taken for the advance learners include quiz competitions and seminars in different departments.
- Provision for participation in various camps arranged by the NSS units.
- Arranging skill development programs in the departments of science and arts.
- Arranginginter departmental speech and extempore competitions, debates, posterpresentations, essay writing competition etc. (WC 361)

For teaching learning purposes, the institute employs experiential learning, participative and problemsolving methodologies in a student centric learning setup.

Institute ensures active participation of students in the whole process of teaching and learning that aims at the holistic development and fruitful learning, which is made possible through studentteacher interactions. The teaching-learning process in the institute strongly focuses on skill development along with the expansion f knowledge and thorough understanding of the subjects. The learning methodologies implemented inside and outside the classrooms include

- Provision of a conducive and opportune teaching-learning environment: Extending an atmosphere for nurturing values, skill development and creative thinking as the first step towards making learning experiential.
- Activity based learning through educational tours and excursions: Field trips/excursions are conducted regularly for the post graduate students of different departments.

- Various subject experts are invited to the institute to deliver their insightful lectures toadd on/updating subject knowledge that augments learning experiences.
- The hands-on techniques followed in the various laboratories areconducted in small group setups, where students not only learn from the teachers but also from their fellow classmates and assistants which in turnencourages participatory learning.
- Project based learning: Certain courses related to science/arts such as Physics, Chemistry, Zoology, Botany, Sociology and Political Science, demands project-based learning. As an integral part of their final semester curricula, the post graduate students work on individual projects and prepare dissertation write ups under the guidance of concerned faculty members.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal assessment is transparent and robust in terms of frequency and mode

Response:

Effective implementation and execution of the evaluation reforms are always aimed at by the institution. The detailed schedules of internal examinations at both UG & PG levels are displayed on the notice boardsfor effective communication amongst the students well in advance before the commencement of the examinations. This aids the students to properly plan and prepare themselvesfor the upcoming examinations. The Head of the Institution asks faculty members to provide their valuable suggestions regardingnovel evaluation methods, which, if found suitable are approved by the institutional assessment committee and followed thereafter. All the decisions and system reforms are also duly notified. It is often taken care by the institution that frequent, continuous and consistent internal evaluations take place properly and effectively.

Hands on trainings/Practical classes are carried out at the various departments like Chemistry, Zoology, Physics, Botany, Geology and Computer Applications and the students are encouraged for timely completion of their work and submission of their laboratory note books. In environmental science, students carry out survey of different areas and prepare their assignment write-ups under the supervision of concerned faculties and the final reports are evaluated and are the integral part of internal assessment.

PG departments of the institution (Political science, Sociology, Commerce and Chemistry) suggest their students to select topics from their respective syllabiand are guided to prepare the individual dissertations as per the norms and guidelines laid down by the university in the prescribed curricula. The dissertations submitted are evaluated by the external examiners during practical examinations. Most of the teachers are in the examination panel of the university and they render their services in setting the question paper and evaluating answer books. These answer books are provided with individual code numbers by the university and the evaluation process in transparent. The marks are filled in the OMR sheets and completesecrecy is maintained until the final declaration of the results.

2.5.2 Mechanism to deal with internal/external examination related grievances is transparent, timebound and efficient

Response:

The institute is affiliated to Sant Gahira Guru University, Sarguja and follows an annual examination scheme as per the university calendar. The institute is the examination center for different private colleges like Girls college and B.Ed. College, Manendragarh, and almost 2000-2500 students take up the annual examinations.

Almost all the teachers are in the panel of examiners for setting question paper and evaluating answer books. Any representation regarding question paper, examination related issues and evaluation is forwarded to the university. During the exam, unfair mean cases and grievances related to question paper are forwarded to the university immediately for necessary actions. The examination procedure is completely transparent.

- The Annual examination Time-Table is displayed on the notice board as well as on the college website.
- Admit cards are generated online and offline both.
- Examination process is looked after by Centre Superintendent and Assistant Superintendents in all the three shifts, viz, morning, afternoon and evening.
- The answer sheets are distributed from the exam control room and the invigilators are in charge of room wise distribution along with the concerned question papers. After completion of the examinations in each shift, the answer sheets are collected and submitted to the control room along with the student attendance sheets for further procedures.
- The invigilators are directed to be attentive & alert while performing their duties. Before onset of exam, meetings are held with the invigilatorstoprovide them the proper guidelinesregarding their examination duties.
- The question papers and answer sheets are kept in safe custody in the Strong Room, and after completion of exams, are sent to university in time for further actions.
- The answer books are coded and evaluated fairly in time and results declared are displayed on the college notice board & website.

2.6 Student Performance and Learning Outcomes

Response:

4.1 Physical Facilities

4.1.1 The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

Response:

The institution has adequate facilities for Teaching-learning viz, classroom, laboratories, computing equipment etc.

Since the establishment of college, in a modest manner and over the course of decades, development of infrastructure has been proportionate time. The college campus is spread over area of 17.65 acre with a total constructed area of 2000 square meters.

The use of chalk and talk method alongside digital mode is practiced in the institution. There are 3 fully equipped and functional smart classrooms with eight fully equipped laboratories. We have 18 classrooms and one seminar hall and one NAAC room equipped with LCD projectors. All classrooms and laboratories have WI-FI facility, there is a computer lab comprising of 45 computers with internet connectivity and an LCD Screen which caters to the IT need of the students. Printing, scanning, photocopying facilities is also available.

Chemistry, Physics, Botany, Zoology and Geology Laboratoriesare situated on the first floor whereas, Home Scienceand Music laboratoriesare situated on the ground floor of the main building. They all are equipped with instruments, specimen, chemicals required for the laboratory studies. Chemistry department has Ph meter, conductometer, potentiometer, polarimeter, colorimeter, BOD incubator etc.

Botany & Zoology laboratories are equipped with various plant and animal specimens, microscopes, incubators, ovens, refrigerators etc. Type of microscope includes mono and binocular student's microscope and dissecting microscopes.

Geology laboratory has all equipments related to subject study

Home science lab is furnished with sewing machine, induction cookers, microwave ovens, There are Musical in the Music department, there are various musical instruments like, Sitar, Tabla and Harmonium, Guitar Manjeera and Dholak

There is a centralized library consisting of more than 22500 books, educational magazines which the students and staff can issue for personal usages. There is one reading room available for daily studies and referencing for the students. (WC 291)

During youth week various competitions like Essay Writing, Poster Making, Drawing, Mehendi art, Rangoli making, Salad Decoration, Flower Decoration, Aarti &Diya decorations are held in the month of December & January every year.
